INTRODUCTION:

A regional cache of medical supplies and equipment has been purchased with grant monies from the National Hospital Preparedness Program. These supplies and equipment are owned jointly by the Upper Cumberland Healthcare Preparedness Coalition located in EMS Region 4. Items purchased for the cache are meant to provide extra capacity for healthcare when responding to or impacted by an emergency or infectious disease event. Purchase of items has been based on hazards common to our region. Based on regional hazard vulnerability assessment, our most likely disaster would result from **Severe Thunderstorm/Straight-Line Winds or Tornadoes** causing multiple casualties or displacement of residents and/or visitors needing shelter. Macon County in the most northwestern tip of our region was struck by an EF3 tornado on February 5, 2008 resulting in 22 fatalities and 63 injuries. Most recently on February 29, 2012, DeKalb, White and Cumberland counties suffered property damage and fatalities related to tornados. Again on March 2, 2012, an EF2 tornado tore through the region causing significant property damage in Jackson, Putnam and Overton counties but fortunately no fatalities. In February 2015, five counties in the region were struck by a significant ice storm that downed trees and power lines leaving some residents without power for more than a week. There were seven shelters opened to provide warmth and food to displaced residents.

PURPOSE:

This document serves to guide emergency first responders, including but not limited to public health, hospitals and 911 operators, through the process of requesting the Region’s supply cache, familiarize them with the inventory available, and provide guidance for deploying and using these assets.

INVENTORY:

The regional stockpile of medical supplies and equipment is located in six pull-behind trailers as delineated below. Four of the trailers remain parked on the eastern end of the Cookeville Regional Medical Center campus at the corner of North Willow Avenue and 6th Street in Cookeville locate at 531 North Willow Avenue. One is a portable refrigerated trailer for extra morgue capacity. One contains a 20-bed portable treatment facility with a pull behind generator. Another has basic medical surge supplies, and one is equipped with the First Water Outpost water purification system and accessories.

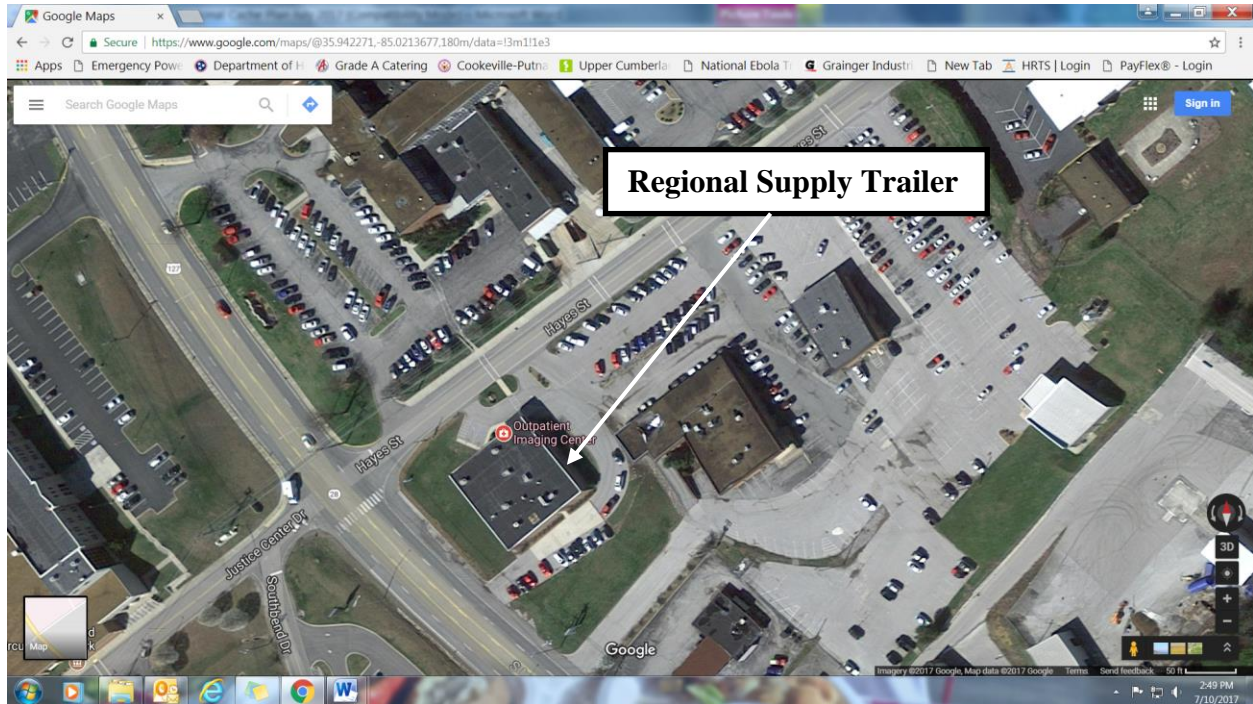

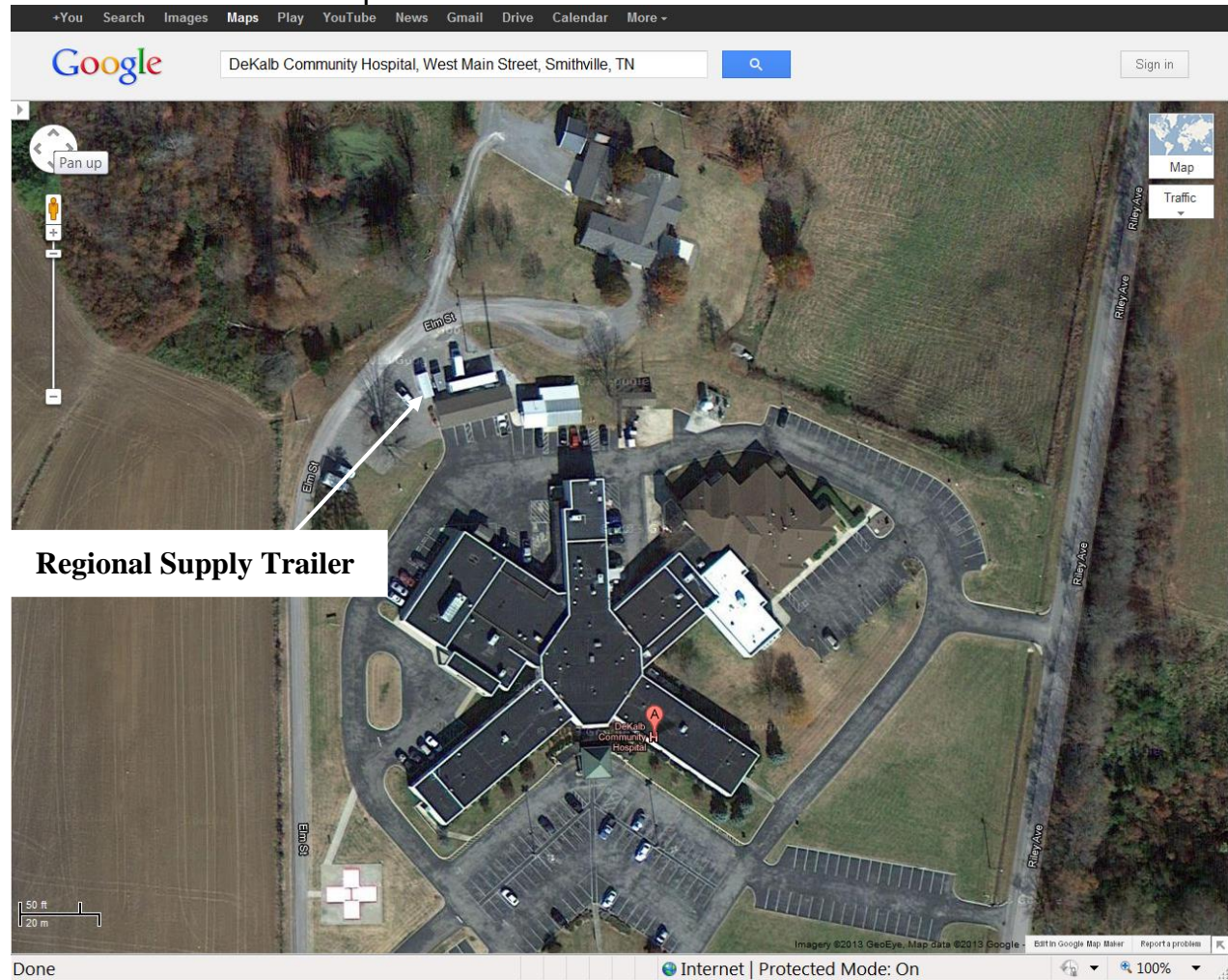

REQUESTING ASSETS:

Because assets are limited and more than one area of the region may be affected at any one time, the assets will be deployed on a first-come, first-served basis. Regional Cache assets may be requested by a hospital, EMS or county emergency manager when any of the following conditions exist in their service area:

- When an emergency that threatens to overwhelm local medical resources has occurred,
- Evacuation/overcrowding of facility,
- Facility water outage,
- Multiple fatalities have exceeded the county morgue capacity,
- Need for Alternate Care Site/Triage Station

Upon meeting the conditions listed above, hospital incident command, county EMS Director or county emergency management may request Regional Cache assets by contacting the Regional Medical Communications Center, aka Cookeville MedCom, either by RADIO or TELEPHONE communications at

MEDCOM RESPONSIBILITIES

The on-duty dispatcher at Cookeville MedCom should obtain the following information:

- Requesting entity Point of Contact name and phone number
- Alternate contact name and phone number
- Brief description of incident

Upon receipt of a request for the Regional Cache, the on-duty dispatcher will contact Regional Hospital Coordinator Kristi Langford. In the event that the RHC cannot be reached, Emergency Response Coordinator Barry Weber will serve as back-up.

PUBLIC HEALTH RESPONSIBILITY:

Upon notification from Cookeville MedCom, the RHC, or designee, will contact the requesting entity to obtain additional information about the incident. Assets to be deployed will depend on the location of the incident and the assets needed. The RHC, or designee, will notify the hospital point of contact responsible for the assets to be deployed.

CACHE LOCATION RESPONSIBILITIES:

Each cache location has an internal policy and procedure related to the cache assets maintained at their facility.

- Each cache location will store and maintain a portion of the regional cache and will serve as the distribution point for these regional supplies and equipment.
- Each cache location will be responsible for the environmental and physical security of the regional supplies.
- Each cache location will designate a Point-of Contact for the cache assets.
- Each cache location will be responsible for notifying County Emergency Management for transport of assets.

Transport of the assets will be arranged by the point of contact at the respective cache location. In the event that the cache location has no one available to transport the assets, the requesting entity will have to be responsible for their own transportation. If no means of transportation is available, transport will be arranged through the RHC working in conjunction with MedCom.

RECEIVING ENTITY RESPONSIBILITIES:

RECEIVING: A designee of the requesting entity shall sign a User Agreement form before the cache is released to their custody. In an emergency, this will most likely be the HICS Liaison Officer or the county emergency manager. In a non-emergency, this will be the person making the request. The User Agreement forms are located on each trailer in the file pockets mounted just inside the door.

HANDLING: The requesting entity is responsible for tracking the use of and assuring the necessary maintenance of cache inventory during the time it is in their custody. Any non-disposable cache equipment shall be returned in clean, workable condition or the requesting entity will pay for the cost of cleanup, repair, or replacement.

RETURN: At the conclusion of the event, the requesting entity will clean equipment, repackage it and transport back to the cache site. Disposable supplies unopened and in usable condition may be returned. The requesting entity shall provide a list of the assets used. Any consumable or damaged cache assets shall be replaced by the requesting entity with same or similar kind within 45 days.
